TUITION AGREEMENT

The following agreement is entered between _____ and "Kidstart Learning Center".

The parent or guardian agrees to the following:

- Pay all assessed tuition during the entire period my child is enrolled for childcare services in accordance with the tuition rate listed above.
- Due to the fact that a complete program must be maintained with full staff on a year round basis; holidays, emergency closings, school closings, and absences due to illness or otherwise are not excluded from the required tuition.
- Pay weekly tuition on the Monday or Tuesday, for the week the services are to be provided, or monthly tuition on the first service day of the month.
 - If the tuition is not paid when due, then a **late fee of \$10.00** will be charged per day.
 - If tuition is over one week in arrears, the child will not be admitted to class until the balance is current and your child's space will not be reserved.
 - Tuition is due regardless of a child's absence from the program for any reason, and is required to hold the child's space.
- A **non-refundable registration fee of \$75** is due at the time of application. If your child discontinues from the program and later re-enrolls, a new registration fee will be assessed.
- The center's operating hours are from 7:00 a.m. to 6:00 p.m. The center is closed for certain holidays – a schedule of which is posted. The operating hours and the holiday schedule may be changed at anytime with 30 day's notice.
 - Severe weather or other conditions may prevent the center from opening on time or at all or close early. In case of early closing, it will be your responsibility to arrange for early pick-up your child.
 - There will not be any tuition credit for any time the center is closed.
- A **late pick-up fee of \$10.00** will be assessed per child for every 10 minutes the child remains at the center after closing. If there are more than three late-pickup incidents, the center has grounds for termination of your child from the program.
- A **security deposit of \$100** is due at the time of enrollment. This security deposit will be refunded once the child graduates or is withdrawn from the program with the proper written notice.
- Two weeks written notice must be provided if childcare services are to be discontinued. You agree to pay all tuition and fees for the duration from the notice, even if your child is not in attendance at the center.
- If you are getting assistance from any charity care program, you agree to abide by their rules and pay their assigned co-pay as well as the difference between their payments and the assessed tuition of the center for your child.
